PA490 LAND ASSESSMENTS:

Presentation given by John Chaponis, Colchester Town Assessor and Joan Nichols of CT Farm Bureau.

Booklets outlining Public Act 490 from the Connecticut Farm Bureau were distributed to the Commission and present citizens.

Joan Nichols spoke regarding the history of PA490 and the need for clarity and participation by all farmers in CT.

Topics discussed included:

- How Determinations are made through questionnaires on land leasing costs by farmers in CT
- Assessment of various levels of soil friability and other types of land usage
- How the results of the assessment reduced the per/acre cost of "tillable A & B"
- John Chaponis said that all Colchester Farm Land was valued at "tillable D", which is the lowest rate for tillable land

Darren Cugno, present citizen, asked for an update on the exemptions of AG buildings. John Chaponis and C. Bourque indicated that this was still ongoing and identification of qualifying local farms was still not available.
