- 6. 2020-2021 Budget Discussions
 - a. C-3 B Bernier spoke about the history of C3. J Burt spoke about School Readiness. C Praisner explained that although the foundation pf the program is to better prepare children for school, the actual programs are social service programs, not educational. B Bernier stated that the School Readiness allows the BOE budget to financially support the program.
 - b. Youth and Social Services V Geato reviewed Youth Service programs at the Youth Center, summer trips, during the school day at the schools and the Substance Abuse Counsellor. She then went on to review the Social Service programs. Full time position not filled yet as the initial outreach was limited as they thought a current employee was interested did not produce enough candidates, now with wider outreach, more candidate

b. First Selectman's report- Bonding the school, PPwk going to bond council. Selling Notes and Bonds on the 8th. SP rating AA+(second highest). SP1+ on the note (highest rating on a note). 7,040,000 bond, 2,845,000 short term note. Intent of the note, represents the 11% the state withholds pre-audit, hoping reimbursement will be received next year to repay the note. R Tarlov commented that the high rating are inspite of the negative State ratings and condition. A Shilosky reported that Dave from Open Gov did presentation to dept heads this morning, Maggie spent time with him.
