- 1. Last week, it was disclosed to me that an additional 750K will be coming to the town; with The Colchester Police Department, The Colchester Senior Center, and the Colchester Food Bank each receiving an additional \$250K.
 - Our town will always be grateful for his generosity and the positive legacy he will leave behind. May his memory be eternal, and his soul forever blessed.
- 1. Last Thursday, Officer John Zavalick was sworn into the Colchester Police Department. He brings over 29 years of experience. I am confident that he will be invaluable to our town. Let's all give him a warm welcome.
- 2. Fiscal 21-22 budget: Will both be balanced and exceed revenue projections. Our town exceeded revenue projections by 900K. That revenue will go into the unassigned fund balance and will now be utilized to lower future expenditures and ensure that this town runs efficiently on a lower mill rate for years to come.
- 3. Town Green Project: Anticipated start date will now be the end of August
- 4. The New Playground: Anticipated start date will be the end of August
