H. NEW BUSINESS -

A member of Eagle Scout Troop 72 was before the commission. On behalf of the Eagle Scouts he would like to construct / reconstruct a couple of bridges in need of repair. This will come before the commission in March with a plan.

I. ENFORCEMENT -

J. Gigliotti reported to the commission for activity at 803 Middletown Road. In January a building permit was received for a pool and a deck; with further review from staff it appeared the pool and deck were going to be situated in the upland review area, and after inspection it had become known the pool and deck were already constructed. The watercourse was pointed out for the commission and the location of the pool and deck. After further review from the commission they instructed Jay to issue an administrative permit for the activity.

J. CONSERVATION -

J. Gigliotti provided a copy of the Town of Colchester Open Space map. On December 18th, the State Bond Commission voted to approve numerous programs, one being Open Space and Watershed Land Acquisition Program, administered by DEEP. The program is accepting applications with a June 1st deadline. There is a 65 acre parcel on Route 16, across from Skinner Road, which is currently listed for sale, and staff is in the process of further review to see if this would be a fit for the application of the grant.

- J. Gigliotti showed the commission photographs of the Windham Avenue subdivision that is underway. The Phase I wetland crossing has been constructed and photographs where shown to the commission; noting that staff is very pleased with the progress so far.
- J. Gigliotti spoke with the Norton Park Committee regarding Open Space and the Airline Trail. They provided staff with flyer showing a conception plan of what the park will look like when complete.
