- **a.** W2021-3063- 59 Cato Corner Road- Donald Dubois-Applicant, Paula Jervasi-Owner, Assessor's Map 4W-09 Lot 019-002, Request for Declaratory Ruling- Proposed Timber Harvest
- J. Gigliotti shared a map with the commission while pointing out the one wetland crossing along with the area of where some road will need to be constructed. Mr. Gigliotti stated this to be a USDA through the NRCS, Timber Harvest Project.
- Mr. Donald Dubois, representing the applicant was before the commission, and provided the commission with more information on the NRCS Grant that has been received to help the owner care for the land. The tree removal process will begin after November 1st, in order to mitigate any impacts to birds roosting and giving the turtles time to go into hibernation.
