Grant applications have been sent to the Lion's Club to request funding support for Making Memories Program, applying for continued funding for the Making Memories Programs through the Title III Grant and the Municipal Grant Program funding that supports our medical transportation services.

The Colchester Senior Center Facebook page was re-launched in late January.

A new chimney liner was replaced at the Senior Center building last Friday.

The Senior Center will be closed on Monday, February 18, 2019 in observance of Presidents' Day.
