Director of Senior Services Report CoA Meeting September 13, 2021

The Town budget will go to referendum for the 3rd time on Tuesday, September 21 at Town Hall. We will be running buses to the polls on that day.

September is National Senior Center Month. Typically the NCOA would roll out a theme for the month, but this year they did not. We selected the Colchester slogan of "Where Tradition Meets Tomorrow." We have a great program called Made in Colchester scheduled in the early evening, which will feature a display from the Colchester Historical Society about the Hayward Rubber Co. and we will have food items from local restaurants, prize giveaways, etc.

With the beginning of fall starting this month, we will be focusing on Falls Prevention with our Annual Falls Prevention Breakfast sponsored by Chestelm Health & Rehab. A free breakfast will be provided followed by a presentation on home safety with a focus on preventing falls in the home on September 29th.

It has been decided that we will not be holding the Annual Holiday Fair and Open House this year due to a number of factors—rising COVID cases locally, our reliance on older volunteers and the increase risk of exposure they would face and the fact that our Program Coordinator will be close to going out on maternity leave, at that time.

Our in-person dining is rebounding. It started slowly once TVCCA reintroduced the program on-site, but now with a few new members utilizing the program, it's getting back to pre-pandemic levels for the Congregate Meals. We have a few people on the Grab & Go style meals and MOW deliveries going out weekly.

This month we resumed in-person exercise classes. Masking is required and many have opted to continue their participation from home via Zoom.

The much requested Lunch Bunch series will resume this month. Ruth has put out a Lunch Bunch Survey, asking for input for future restaurant destinations.

There are several new programs which have launched—a watercolor workshop series and a line dance class, Choral Group is practicing again weekly and a Zoom-based AARP Safe Driver Class is scheduled.

The Renters' Rebate program will be ending on October 1st, and Energy Assistance Programs begin this month.
