## Director of Senior Services Report CoA Meeting December 12, 2022

Open Enrollment for Medicare ended on December 7<sup>th</sup>, and any plan changes will take effect beginning January 1, 2023. Thanks to Senior Resources, we had two very busy Open Enrollment Events. 36 people were served.

The Budget Referendum held on November 15th passed.

The New Senior Center Project is stalled awaiting the outcome of a Court Hearing scheduled for December 20<sup>th</sup>. Two citizens filed an injunction against the Town to prohibit Town leaders from utilizing any additional resources over the approved \$9.5 million approved at referendum, such as the Bendas' Bequest. Citizens (many of whom were seniors) spoke out in frustration during Citizens Comments at the well-attended BoS Meeting on December 1<sup>st</sup>, upon learning that the project has been halted.

CSC donated a 4' tree to the Wadsworth Annual Trees and Tradition Festival. This display has not been held in several years due to the pandemic. Jodi Savage, Program Coordinator and talented crafters worked to fabricate all of the decorations in a theme which honors Colchester's history of poultry farming. The exhibit will be running from December 2-12.

We have a fun variety of seasonal activities, meals and outings this month: Holiday Lights Trip to Goodwin Park, Cocoa & Carols Sing-Along, Cookie Decorating with YAC, Hanukkah Celebration with Rabbi Alter, Holly Daze Luncheon, New Year's Brunch 'n Bash, Make, Take & Give Crafting Series, Card Writing Session, Gingerbread House Edible Craft & more!

This year, we no longer have volunteers to provide free snow removal services. If anyone knows of any affordable and reputable companies or individuals, I'm working to put together a resource list for both plowing for driveways and snow blowing/shoveling for walkways, stoops, etc.

We are supporting a Poinsettia Sale to support the Walk to End Alzheimer's. Plants can be purchased for \$15 through our office and will be available for pickup on December 20-23<sup>rd</sup>.

We are once again partnering with JJIS for the Annual Holiday Box Program. This year 25 seniors will receive gifts and cards from a classroom, delivered to their door. Boxes will be delivered on 12/23. We will not be bus transportation that day, to enable staff to deliver boxes before our early closure that day.

We are running a Season of Giving Food Drive during the months of December and January to benefit the Colchester Food Bank.

Senior volunteers will be assisting Santa's Anonymous in Town by assembling holiday stockings filled with treats which will be delivered to children throughout the community.
