 - A. <u>W2017-3019</u>-Incord- applicant/ owner, 151 Upton Road, Assessor's Map 09-00 Lot 008-005- Proposed commercial development with associated parking & drainage facilities, Activity within URA *DRD* 1/12/18
 - J. Gigliotti was before the commission to review the application. This is for development of a warehouse with parking facilities. There is no direct impact to the wetlands, only 2 areas that are in the upland review area. All comments and concerns from town staff have been addressed with the current revision.

Ellen Bartlett, CLA Engineers pointed out the wetland area, and the existing vegetated area that is remaining as they are today, which in total is about 25' - 30'. All the roof drainage is going into an infiltration system, with an overflow pipe for a 100 year storm.

J. Gigliotti was before the commission to review the application. A report was handed out that was compiled by Bob Russo, CLA Engineers. This property has an existing building. The impacts are upland review areas. The development will go to the West of the existing building. The previous delineated wetlands from 2007 has changed to the 2017 delineation the commission has before them today. J. Gigliotti provided a clear explanation, that it was not the soils that have changed but the flow of the watercourse. He also confirmed with the commission that all comments and concerns have been addressed by town staff.

Bob Russo, CLA Engineers, discussed the boundary of the wetlands and gave a description of how the watercourse flows thru a pipe outlet and works its way to a culvert that is off the property.
