The Commission has bi-monthly meetings and meets as needed to address pending complaints and requests for advisory opinions. The five-member board is appointed by the Board of Selectmen. *To qualify to serve on the Commission the applicant must be a town resident and registered voter, and have a strong commitment to uphold the Code*. Colchester Ethics Commission By-Laws

The Commission and its members shall conduct the business of the Commission fairly and equitably, and shall serve as a model for the Town in *upholding and administering the Code of Ethics*.

The Commission *meets as scheduled and* as necessary in response to a filed complaint, a request for an advisory opinion or to conduct any pertinent business. (*Reserved meeting time is no longer correct and deleted.*) Please check with the Town Clerk or the town website for meeting dates and times.

The Commission shall make decision by consensus whenever possible and will follow Robert's Rules of Order, as required by *State* statute and *Town* ordinance.

The Chair, in consultation with members and staff, shall provide necessary budget information to the *First Selectman*.

The Commission may add to, delete from or amend these by-laws as deemed necessary.
