The selected individual will report to the Public Works Supervisor and /or Director of Operations and may occasionally supervise other Maintainers within the Public Works Department. Qualifications include, a thorough knowledge of tools, equipment, and work methods and practices used in the general maintenance and improvement of public highways, ability to operate, service, and make minor repairs on light and heavy duty highway and construction equipment. The Maintainer II performs a wide variety of skilled and semi-skilled labor tasks relative to the maintenance of Town roadway infrastructure, parks, grounds, and buildings. The selected individual must possess a valid Connecticut Class B operator's license, have passed CDL testing, and possess some supervisory skills. Performs a wide variety of skilled and semi-skilled labor tasks relative to the maintenance of Town roadway infrastructure, parks, grounds, and buildings. Available to perform/assist as needed for natural or man-made emergencies.

- A general knowledge of tools, equipment, materials, and work methods and practices used in the general maintenance and improvement of public highways, parks, and buildings.
