Discussion of Content of Minutes

K. Kosiba would like to see more content in the minutes allowing members to review for details of discussions. The clerk noted that the minutes legally need only to have motions and that great detail is not required nor suggested. Chair Misbach said each member could keep their own notes for the details they are looking for.

4. CITIZENS' COMMENTS

None at this time.

5. STATUS REPORT FROM JIM PAGGIOLI

Director Jim Paggioli reported that the Request for Proposal (RFP) is out and several contractors have responded. Bids will be opened July 26, 2021. A thirty (30) day notice must be posted prior to the house demolition.

Discussion followed about the amount of fill available and the amount needed, the possibility of a design change due to the fill areas and placement of safety fence sections. When the demolition and cleanup are completed, the property will be seeded to stabilize the area.

6. AMENITIES

P. Reading will update the materials list and send out to members for review and discussion at the next meeting.

7. FUNDRAISING UPDATE

K. Kosiba reported that the total of the monetary donations to date is \$27,536 including the recent grant. The committee has received \$17,660 for amenities (benches, bricks, etc.) This is a total of \$45,256 less \$568.49 for expenses.

J. Cameron suggested several new ideas for fundraising. N. Wasniewski would like to send a letter thanking the groups that presentations were given to and request a donation.

Flyers will be available at the Colchester Land Trust booth during the Farmers' Market on Sundays.

8. GRANTS

K. Byrne is working with Jay Gigliotti to complete the \$20,000 Eversource Grant. There is a state grant that will match funds raised by this committee. A value for Phase I to be completed for the opening of the park has been set at \$120,000.

In April, informational packages were prepared to be sent to Goodwin, UCONN, Naugatuck and other area colleges and to Master Gardener programs in New London and Middlesex counties to request landscape design students to participate in the landscape design at the property. This proposal is to provide student with an authentic learning experience. K. Kosiba will be the contact person for respondents.

9. PICNIC TABLE/BENCH SCOUT PROJECT

K. Kosisba has been in touch with an anonymous donor regarding the picnic tables. He would like to make all the tables for the park. As this was a potential Eagle Scout project, K. Kosiba presented a photo of a wood and concrete bench with a back that scouts have made for other areas, giving the scouts a possible project.
