Facilities: N. Kaplan looked at the fields recently and said they looked good, though there were some bare patches of grass (i.e. the football field). Apparently, the grass seed that was put down was mainly crab grass and over time it becomes bare. The question was brought ups as why the town will not allow the leagues to do any preventive maintenance to the fields. Per E. Kundahl it has a lot to do with the contract with the Public Works Dept. In the past, volunteers have helped maintain the fields. Also, the town ordinance prohibits any herbicides to be used on the fields where kids play. No pesticides can be used on the K-8 school fields but the RecPlex is ok. Have the laws been changed? If so, can we change the ordinance to reflect that?

T. Quinn that everything except the floor and that is because the floor was not in the budget.

Finance/Administration: M. Pulse will send out an email with regard to how much money is in the field sustainability fund to date. This information will be helpful in fielding questions about the fee. N. Kaplan thinks that the \$40K could be used to start the process. T.Quinn asked if the leagues knew that the cost of water to run the system will come from them and most of them do know that they will pay for it.

BOS: D. Mizla reported that if there is a new Selectman that the swearing in will take place on November 18<sup>th</sup>. She also reported on the Blue Energy Project that will bring the town over \$9.7 million over the next 20 years through personal property taxes. The power will go back to the grid. The gas lines will run down Rte 354 and Blue Energy will pay for that and the repaving. There may be a chance that the town facilities can be hooked up to the grid. First payment is in 2020 0r 2021 for \$500K. Stan Stoby is not up for re-election and a going away party will be held on Thursday.
