

- 1. CALL TO ORDER J. Mathieu called the meeting to order at 7:01 pm.
- 2. APPROVAL OF MINUTES January 16, 2019
 B. Hayn MOTIONED to APPROVE the minutes of January 16, 2019. SECONDED by J. Tinelle. All members voted in favor. MOTION CARRIED 6/0

3. PUBLIC HEARING-

A. Proposed Regulation Amendment: Colchester Land Development Regulations, Section No. 11, Signage. (Continued from January 16, 2019)

D Schaub provided the board with a summary of the proposed changes from the last meeting. Proposal can be viewed in the Planning and Zoning office.

D Schaub reported to the commission a request received from the First Selectman's office requesting the Planning and Zoning Commission continue the public hearing until the next regular scheduled meeting. Town staff was notified that Mr. Soby was unable to attend the meeting this evening due to travel complications. The request is to allow town staff additional time to arrive with a compromise with the area businesses for the use of feather flags.

Jack Faski, Colchester Business Association, submitted letters received from Mr. Faski, Dorothy Sightens; Hair Magic Salon, Scottys Frozen Custard, Dave Cogi; Smarter

Appliances, all requesting the commission consider the businesses be allowed to continue to use feather flags as they feel they are very important in promoting their business.

Michael Scalise, Local Independent Business Owner; provided the commission with a printout titled "Community Reinvestment & Local Re-circulation of Revenue" providing estimates and conclusions based on the Studies of Civic Economics. Mr. Scalise gave an overview of the presentation, provided the members with copies of the report and asked for them to take the time to review. A copy of this report can be seen in the Planning and Zoning office for public review.

George, Dunkin Donuts, noted the local businesses that put money into advertising to make money and feel the feather flags can be an expensive investment, and understand they should be maintained, however feels they do generate businesses a significant amount of revenue.

Michael Hinchcliffe, talked about promoting businesses and how welcoming businesses can be successful and feels working together is important.

Chuck Maynard, VP of Colchester Business Association, asked if the board has been able to come up with a compromise or solution for the feather flags that would be both beneficial to the businesses and the community as a whole. Chairman Mathieu stated the purpose of the public hearing is to take in testimony from the public on the issue and the members will listen to the testimony that is presented, take the evidence that is presented and after all is heard, deliberations will take place.

R. Benson for the record stated to the commissioners and the public that feather flags are & have always been prohibited. The proposed regulation change that is before the commission is a result of the numerous violations in town that are not following this current regulation. Feather flags and temporary flags have been prohibited in the Town of Colchester and noted in the Colchester Zoning Regulations dating back to 1959.
