- S. Melingonis said there have been some questions about carpeting and roller shades. There
 have been meetings with the contractor providing the shades to work through the issues and
 questions.
- The client will review FFE options on Monday.
- A company is coming to school next week to do a demonstration on the touch screen boards.
 The board the school staff would like is not on the State Contract list. P. Daly said that the school would need to show the benefits of this board and that it is the only one that meets the needs. There are 55 boards being purchased so reimbursement needs to be guaranteed.
- A. Tarnowski requested that any "loose items" that might result in a PCO be tied up.

8. Construction Manager update and potential action:

- G. Kotait showed pictures of metal panels being produced and reported that they are about half way done with production.
- Boilers will be started mid-February.
- Additional pictures were shown of areas such as the bleachers that will be refurbished and ADA cutouts.
- Permanent power is now on.
- Permanent heating will be on soon and is needed for the flooring to begin.
- The project remains on schedule.
- P. Picard expressed dissatisfaction with exposed insulated piping. S. Melingonis said that white Armaflex can be used in the areas where the pipes are exposed.
