1. Call to Order: Chairman Tarnowski called the meeting to order at 7:01 p.m.

- 5. Approval of minutes of October 19, 2022: R. Silberman motioned to approve the minutes of the October 19, 2022 meeting amending to reflect discussion of further savings as well as long term savings from a metal roof compared to asphalt shingles. K. Hastings seconded the motion. Members voted via roll call. All members voted in favor with S. Nadeau abstaining. MOTION CARRIED.

- 7. Approval of Invoices

 - b. Silver Petrucelli: S. Nadeau motioned to approve Silver/Petrucelli invoice number 22-1157, dated 10/01/22, in the amount of \$17,264, seconded by J. Ruiz. Vote was done via roll call. Vote was unanimous. MOTION CARRIED.

- 8. Discussion of Contract with BRD Builders and Additional Funding Sources: Chairman Tarnowski met with BOS Liaison R. Coyle, BOF Liaison A. Shilosky and First Selectman Bisbikos. They feel the most feasible way to fund the million dollar funding shortage would be to use \$500,000 Bendas funds, \$300,000 from undesignated fund balance, and \$200,000 from ARPA funds. According to the town attorney and bonding council, using these funding sources can be used without having to go back out to referendum. Boards do not want to commit to that money prior to the budget referendum. After the referendum a joint meeting wil be held with the boards and the building committee to further discuss how to address the funding shortage. Chairman Tarnowksi spoke to Bob O'Brien making him aware of the timeline; bid amount can only be held for 90 days. He can have the contract to the potential builder by mid December. CSG, S/P, and Chairman Tarnowski are going to meet with BRD Builders tomorrow to update them on the process. S. Nadeau asked about the possibility of going out to bid again. C. Nardi said that is risky as bids could come in higher. He does not think the cost would differ greatly. Chairman Tarnowski reiterated that the decision on how to proceed is in the hands of the BOS and BOF. He sees the possibilities as being: BOF and BOS make a transfer of funds, go back out to referendum, send the project back to the committee and tell them to bring the cost down, or disband the committee and put together a new committee.
