4. CONSENT AGENDA:

- **5. CHAIRMAN'S ADDRESS:** Donna Rosenblatt spoke briefly regarding the supreme court case, Sackett vs. EPA regarding wetlands issues and the Clean Water Act. She encouraged the Commission generally to follow this case. Donna indicated that the "pumpkin drive" had gone well, and there were still pumpkins available.
- **6. NEW BUSINESS:** Discussion regarding the post-holiday Christmas Tree collection implementation. Carla Roselli had submitted a request last year, and volunteered to resubmit this request with her address and Donna Rosenblatt's address as drop off points.

Carla brought up an additional issue regarding the "Farm Spotlight" that has been on the First Selectman's Blast recently. This spotlights Colchester farms. Carla's farm, Timberdoodle, was highlighted, but her address was included, even though she expressly asked that it not be included. Although Carla sells goats, she is only open by appointment, and her goat sales are usually arranged via down payment.

Realizing this was a privacy issue, Rosemary Coyle indicated she would call Town Hall and institute privacy guidelines for the Farm Spotlight.
