I also submitted this via the form online, so my apologies if there's duplication. Please include the following letter in the Board packet of official correspondence for tomorrow's night meeting. Unfortunately, I may be unable to attend in person and would therefore also like for it to be read.

So that the public is well aware, the email that Jason is so concerned about was between myself and other Democrats using personal email addresses. We were discussing how we mark voter tendencies in the voter contact tracking system used by all Connecticut Democrats statewide called VAN that is referenced in the email.
