Exterior -

Existing glass and storefront material are to remain.

Install new half inch plywood as per the attached drawing with screws.

New brake metal (color to match existing) to be installed over new plywood (One piece, should be wrapped on top of existing horizontal window mullion).

Install Ice & water & new flashing (height to be equal with neighboring flashing).

Interior -

Existing glass and storefront material are to remain.

New 1" ridged insulation on top of glass.

New 5/8" gyp board secured to storefront metal.

Reuse existing angled cap strip at top on new gyp board.
