My apologies for not being able to attend tonight's meeting in person however, I would like to take this opportunity to provide comments in support of increasing the annual budget for future open space funding and stewardship. The town of Colchester recognized the need to set aside funds to protect open space and began contributing \$5,000 during the 2004-2005 fiscal year. Since that time, the town has grown and we have seen a number of large parcels converted to new subdivisions and retail outlets. Fortunately, the town has used the open space fund to acquire key parcels such as the Ruby Cohen property, two additional adjoining properties to Ruby Cohen (allowing the town to increase the acreage on the original parcel) and then most recently funding will be used for the 65 acre parcel that was part of this years DEEP Open Space grant.

Hi Mary;

I read through your email regarding the increase of 8+% in the town budget. While this is high, I do understand it, but I believe their are ways to save money. You mentioned road salt costs, and I'd like to expand on that just a bit to include snow plowing. Every year it floors me to see how much salt is dumped on our roads, when neighboring towns do not do the same. Repeatedly this past year, and every year, I have watched excess amounts of salt scattered on our roads when the temperature is not forecasted to fall

below freezing or when no precipitation falls. Even when precipitation falls, the amount of salt used on the roads is extreme. Unless the salt is plowed off of the roads, it remains for weeks, often as piles at intersections. This is extremely wasteful and extremely harmful to our environment and it needs to be addressed immediately. And not only is the spreading of salt excessive, but the amount of plowing is as well for small amounts of snow. On many instances every season, I witness plows driving down the town streets with their plow down and nothing on the road, to the point where sparks are flying from the plow. In addition, for even the smallest snow falls, the trucks plow my cul-de-sac 3, 4, or even 5 times in one evening. This drivers either really like driving or they are collecting a ton of money in overtime. Can we please think efficiency? This is wasting man power, fuel, and damaging our roads and needs to be rethought with conservation in mind- conservation of time, money, resources, and our environment.

We need to start spending money like it's coming from our own pockets, which aren't very deep. Please have our town think about ways to increase our efficiency, which will lower our costs. Hope I understand the question.

If at the time the proposed budget is prepared, there are still contracts expiring on 6/30 that have not been ratified, an amount of money is set aside in the HR department budget (page 111, pdf page 113, of the 2020/2021 budget) last line, "Contract Settlements". Once the contracts are settled, the money representing the settled contract is moved to that department's salary line items.

Public Works was in negotiations at budget time last spring.

There are three expiring on 6/30. Don't know current status of those three. They will be in the budget book presented next week.

If the contracts were settled before the proposed budget is presented the increases would already be in the salary lines for those departments.

As there is only a short period from the first public hearing to the Town Meeting date, the contracts are generally not settled between those two dates.

Rob,

Good day. Just curious as a taxpayer.

Collective Bargaining agreements represent a pretty good chunk of the budget. They are large in scope across many different taxpayer services. They also are major driver of increases with their step clauses. Some step increases can be significant annual increase ranging 6% and higher.

Is there any recent public record of what % of Town and BOE appropriations are from collective bargaining agreements?

My recollection is the Town provides this information in its approved budget submission after the referendum. Can this be provided before the vote in the proposed budget?

The BoE I believe still does not. Any chance the BoE can be asked by the BoF to provide information?

Some years there are negotiations where the compensation must be estimated by the CFO prior to final agreement. The BoF is asked to approve that estimate. Is the BoF appraised by the CFO of the estimated impact in the budget proposals?
