  - B. The Board authorizes the First Selectman to sign the "Non-Residential Renewable Energy Solutions – State, Agricultural and Municipal Agreement" between the Town of Colchester and Silver Brook Solar, LLC, as the same has been reviewed and modified by the Town's legal counsel.
