Dear Sgt. Rondinone,

I am writing to you directly to express my concern regarding a statement that was made during the Police Commission Meeting dated April 26th 2021 by one of your officers.

Officer made a reference about the past commissioners that sometimes the running joke in his office was that they were going to make decisions for the water department when they didn't know anything about water. He also mentioned that Chairman Stavola was the only chairman with prior police knowledge.

I find this statement alarming and offensive. The comment that Officer implies that civilians have no business being on the commission. All Commissioners I have worked with have spent countless hours attending meetings, doing research, participating at special functions all for the better of our community. These actions are to be commended not ridiculed or to make fun of. The commission goals have basically remained the same. Unfortunately, it was the lack of support from the management that yielded in no past results.

Perhaps you are unaware prior to your employment in Colchester I connected with Mayor Bob Chatfield from Preston to discuss increasing extra duty fee's and how those funds were used to pay for weapons and purchase police cars. I did this on my personal time for the interest of our commission. It was presented and was the failure of the police department for not executing it.

Our Police Commission goals have basically remained the same from year to year. I am alarmed as I feel that your department only responds to topics brought up by our current commissioners with past police experience. Although I find value in having ex-police officers at the table I also see the value of civilians.

I have had several conversations with Chairman Stavola regarding the purchase of a trailer, repairs on the shed and even your office environment. That has been a topic for me for years as I was listening to you all and heard the total frustration in your voices. I didn't forget.

I now clearly see why our commission has had significant turnover throughout the years. I feel it is because your officers prefer to work with ex-cops than civilian volunteers.

I would like to mention, although we may not be former police officers we all are valuable members of the commission. Our commission, made up of civilians and past police officers offers a great check and balance for the police department and community. To make a statement and say that any chairman is the reason for the results is unjust and just short-sided.

Bravo! As a woman civilian and an active member of this commission and community I feel your police officer cut down board women civilian members with slight. I heard the attack on me

I can't help but wonder if additional diversity training is necessary with this officer.



To the Board of Selectmen:

I am submitting this correspondence as a formal complaint with the following two points:

- 1. I have had the opportunity to review the interview packet submitted by Mr. Stavola and in fact the term "removed" was used; however, the nature of his removal was not disclosed. I find it disheartening that certain members of the Board of Selectmen were aware of the nature of his removal and failed to disclose it during the public meeting. I do understand that I had the opportunity to pose the question during that interview; however, I know the truth now and I would be remiss if I did not act on behalf of my constituents.
- 2. With regard to the complaint filed by Vice Chairman Vaillancourt dated May 3, 2021, there are three concerns that I gravitate toward immediately:
 - A. That Vice Chairman Vaillancourt is being denied access to information and is being put into a position to support data and/or conclusions that are being presented to the public without taxpayer oversight.
 - B. That Chairman Stavola additionally is behaving as a bully and creating a toxic working environment, subjecting commission members to ridicule and what amounts to public votes of forced allegiance.
 - C. That both Chairman Stavola and First Selectman Bylone are fostering an environment of unprofessionalism counterproductive to the mandate of the commission.

The First Amendment right is afforded to everyone as evidenced by the Police Union's stance on Officer right in commenting, albeit they were demeaning. I would argue that an officer acting in his/her official capacity should be held to a higher bar of professionalism. It would appear not everyone present held that belief, as witnessed by the fact that Stavola and Bylone did nothing in their leadership capacity to address this inappropriate behavior which could be construed as insubordinate, disrespectful and should therefore be actionable.

The fact that there seems to be a disconnect by all parties regarding the role of the Police Commission leaves me troubled. The Police Commission's role is to act as taxpayer-based oversight entity to provide transparency and accountability to the public in conjunction with management as to the operations of our local police force.

In conversations with Vice Chairman Vaillancourt, she has stated that she did in fact ask for supporting data both on the political removal of the SRO and the police crime and call statistics that were being used to present to the public. This request for data was not provided to Vice Chairman Vaillancourt. As a result, Sargent Edwards presented inaccurate data to the public to justify the addition of two additional police officers on the basis of increased call volume and overall crime.

Both Chairman Stavola and First Selectman Bylone unilaterally worked on the data that ended up in the police presentation to the public. When the inaccuracies between the two budget books were brought to light during a public Board of Finance presentation by Mr. Bisbikos well over a month ago, the public was promised by the First Selectman Bylone that this would be examined and rectified. To date, the data has not been corrected in this year's budget book. As a result, the public will be asked to decide at the town's referendum based on inaccurate data. There needs to be an explanation as to why that data

was inaccurate and why it still remains that way. The truth of the matter is that both call volume and crime has been declining. A noteworthy point to mention is that Chairman Stavola also attended other boards and passed the inaccurate data to them to create a false narrative to justify the additional officers.

The Police Commission held a special session that entered into a closed-door executive session hearing to discuss the actions of both Vice Chairman Vaillancourt and Officer Vice Chairman Vaillancourt was denied her statutory ability to call for the discussion of her actions and performance to be public. As a result of this denial the commission proceeded to engage in an illegal meeting. Two quick points here. 1. Vice Chairman Vaillancourt refused to participate in the session. 2. Had the Vice Chairman entered into this session she would be precluded from publicly disclosing any topics of discussion in order to defend herself.

The following is the statute outlining executive sessions:

"(6) "Executive sessions" means a meeting of a public agency at which the public is excluded for one or more of the following purposes: (A) Discussion concerning the appointment, employment, performance, evaluation, health or dismissal of a public officer or employee, provided that such individual may require that discussion be held at an open meeting; (B) strategy and negotiations with respect to pending claims or pending litigation to which the public agency or a member thereof, because of the member's conduct as a member of such agency, is a party until such litigation or claim has been finally adjudicated or otherwise settled; (C) matters concerning security strategy or the deployment of security personnel, or devices affecting public security; (D) discussion of the selection of a site or the lease, sale or purchase of real estate by the state or a political subdivision of the state when publicity regarding such site, lease, sale, purchase or construction would adversely impact the price of such site, lease, sale, purchase or construction until such time as all of the property has been acquired or all proceedings or transactions concerning same have been terminated or abandoned; and (E) discussion of any matter which would result in the disclosure of public records or the information contained therein described in subsection (b) of section 1-210."

Considering these details, one could most certainly draw the conclusion as an elected official and as a taxpayer that both Chairman Stavola and First Selectman Bylone got caught in a lie. As a result of being caught they are using their political influence to silence and remove an individual that exposed this deception. I personally believe that Vice Chairman Vaillancourt has served in the best interest of the citizens of Colchester and in fact should be commended for attempting to provide the transparency that we all deserve.

I would also be remiss if I did not mention the fact that the Board of Selectmen is choosing to not address Vice Chairman Vaillancourt's complaint against Chairman Stavola, which was issued first and entered into the public record during the May 6, 2021 Board of Selectmen meeting. There was no discussion allowed under correspondence to address the complaint. However, we are allowing for a complaint based on political retribution to be strongly considered against Vice Chairman Vaillancourt.

As a side note Vice Chairman Vaillancourt also submitted her complaint to the Diversity and Inclusion Committee, which is comprised of all females, of which two sit on the Board of Selectmen. I find it difficult that there has been zero engagement by the committee to communicate with a woman who is asking for help to address a toxic working environment. An example of this would be Chairman Stavola forcing a public vote of confidence in a Police Commission session after news media articles addressing his removal.

On a personal note: Chairman Stavola's wife attempted to publicly slander me by making false statements to the Rivereast newspaper in the April 23, 2021 edition. I rebuked her claims in the following week's paper, clearly restating my comments that actually were made and recorded both online and during the Board of Finance Budget Workshop via Zoom. One must ask the question, was she acting as his proxy? Furthermore, Chairman Stavola issued a false and unsubstantiated quote he attributed to Mr. Bisbikos in the May 14th edition of the Rivereast in an attempt to slander and politically assassinate his character. All this in an attempt to move the publics eye away from the complaint issued by the Vice Chairman against Chairman Stavola outlining his bullying, lack of professionalism and outright lying to the public.

In closing, it saddens me to see Our First Selectman acting unilaterally as a bully and perpetuating that behavior in eliciting the assistance of Mr. Stavola to do the same to push a political agenda. I am asking that the Board of Selectman join me in correcting this mistake by placing a motion on the table to remove Chairman Stavola.

I ask that this correspondence be added to the minutes of our next meeting and that the topic be included as an agenda item as well.



Jim Stavola Police Commission Accomplishments 2008-2009

- "Police Applicant Interview Assessment Process and Form" where all applicants were asked the same interview questions and receive a numerical scoring in various categories. This process and form standardized the interview process and greatly reduced the Town's liability should an applicant choose to challenge its hiring practices.
- 2. "Cruiser Repairs" Funds were located in the Town's Emergency Equipment Fund to have the police cruisers repaired. Cruisers were unable to be turned off due to poor wiring which drained the vehicles' battery. Prior to the repairs the vehicles were running at a cost of \$4.00 per gallon only to waste the taxpayers' money and place additional wear and tear on our vehicles.
- 3. "Fund Raising Process" which was acceptable and approved by the Board of Selectmen to allow the Police Commission to raise money through citizen donation for police budget shortfalls, youth scholarships, cancer research, etc. The events would give the Police Commission and Officers community visibility and trusted relations with its residents.
- 4. "Police Website Enhancements" Created a draft document to be an excellent source for the Colchester citizens to become aware of our Town's bicycle and child safety programs, Internet safety and identity theft resource, drug program education and wellness, etc. In addition, links to have citizens ability to view police code of ethics, town stats, photo gallery, press releases, career opportunities, Police Commission Project Log were suggestions to also be included.
- 5. Drafted a "Colchester Police Youth Program" waiting to be presented to the Police Commission and Board of Selectmen with the intention of conducting a simulated law enforcement program for students who have completed their junior year in high school and have expressed a desire to enter into a law enforcement career.
- 6. "Police Inventory Supply Process and Form" Eliminated shortages and overstocking of department supplies to avoid wasteful spending. The procedure assisted the resident trooper supervisor in knowing what equipment is needed.
- 7. "Police Commission Project Log" Created to assist the Police Commission in tracking the status of all 'work in progress' projects. The Project Log is updated monthly to ensure Police Commissioner accountability and project progress when reporting to the First Selectman, Police Officers, and citizens as to the status of ongoing projects.
- 8. "Research and Reporting" Monthly basis in active researching and contacting Chiefs of Police to determine what state and federal grants may be available to our Officers, Board of Selectmen and Police Commission for the good of the Town.

Jim Stavola volunteered for community events and fundraisers for less-fortunate individuals. He was known as a community service officer before "community policing" was a popular trend in law enforcement.



All the Town Hall Departments are open. The Senior Center will likely not be opening after

The Schools are working on a reopening plan for this fall.

The Town has been dealing with significant issues related to the servers, and Novus Insight is working diligently to resolve these.

The gas line is almost completed. Halls Hill Road work has begun, Paper Mill Road Rehabilitation is ongoing.

The approved budget is now posted online at the Town Website.

17. LIAISON REPORTS

Senior Center Building Committee - R. Coyle reported that the Committee approved two invoices from Silver Petrucelli. They have a consensus on Design #12 and the architect will begin working on that design to create a final plan.

Long Term Recovery Committee- R. Coyle reported the COVID impact survey has gone out to residents and will close on July 20, at which point a survey will go out to business owners. The surveys are trying to assess the impact that COVID has had on the Colchester Community.

Commission on Aging – R. Coyle reported that the Commission elected their officers and still needs [moved] two alternate[s to] members [status]. The COA Annual Report was presented to the Board of Selectmen.

Open Space Committee — The DEEP Grant for \$150,000 to purchase property on Middletown Road was submitted. An application for a subdivision on Stanavage Rd. recommended fee in lieu for the open space requirement. Salmon River Watershed Sampling Project is seeking volunteers.

Board of Education — D. Mizla reported the BOE is forming a Diversity Committee to get a scope of what the committee will be doing. Reopening plan must [has to] be submitted to the state by July 24, including three plans 100% back in school, a hybrid of 50% in school[,] and 50% distance learning, and 100% distance learning. Students to return to school on August 31st.

Norton Park Committee — D. Mizla reported that Patricia Young, with an organization that works with the 8-mile watershed, did a presentation to inform the group about the watershed.

Planning and Zoning — T. Rudko reported that the Commission discussed development within the town center district, and the differences between allowances and special permitting, and adjusting the amount of density of housing units. There is an interested party in the Hilltop Marina property.

Historic District Commission – D. Turner reported there were two meetings on the green to discuss the grant the town has received to make improvements on the green. This includes resurfacing the green, making improvements to the gazebo and other landscape improvements.

Board of Assessment Appeals – D. Turner reported they met briefly to reverse a [an incorrect] decision that had been made about an automobile.

CHVFD Exemption Revision Committee – D. Turner reported that they are currently working on eligibility requirements.[,] Once those are in place, hope to get the ordinance revised and brought [to get it] back to the BOS.

Police Commission – FS reported that the Police Commission approved the permanent selection of Sergeant Tim Edwards. They discussed the requirements for the Corporal Position. They discussed the requirements coming from the state government including body and vehicle cameras.

Sewer and Water Commission – FS reported that the commission discussed the sewer main break and the repairs that are needed.

Conservation Commission – FS Reported that the commission is looking into a situation where someone is filling in a wetlands area.

5.3 Police Commission Operating Policy

<u>Purpose</u>

The Police Commission, First Selectman, Resident Trooper Supervisor, Board of Selectmen, and Board of Finance all have some role in the makeup and operation of the department. In order to ensure that all parties have a full and complete understanding of their roles, the following policy is adopted.

Administration

- 1. The First Selectman's office is the Human Resources office for the town.
- 2. All personnel information including, but not limited to offer letters, disciplinary matters, and grievances shall originate from the First Selectman's office.
- 3. All personnel information shall reside in the First Selectman's office.

Chain of Command

- 1. Commissioners shall respect the order of command as set forth in the Colchester Police Rules and Regulations Manual at all times.
- 2. Individual commissioners have no authority except as stated in ordinance 18-31 which is "Liaison officer to Division of State Police". Only the commission acting as a body has authority.
- No commissioner shall issue orders or requests to officers. Such requests will be directed to the Resident Trooper Supervisor or his designee.
- 4. Commissioners shall understand that they do not have any police powers within the town of Colchester.

Communication

- 1. As stated in the charter, the commission, as a body and as individual officials, reports to the First Selectman.
- 2. The commission shall respond to any request from the First Selectman as soon as possible by discussing at the next regular commission meeting or by calling a special meeting if necessary.

3. The First Selectman shall respond to any request from the commission in a timely manner

Rules and Regulations

- 1. The commission shall keep the rules and regulations governing the police department current and in accordance with applicable laws and best practices.
- 2. When advised by the Resident Trooper Supervisor that a rule or regulation needs to be changed, the commission shall enact such change within three months or provide a reason why they are not able to do so.
- 3. The commission shall abide by the Colchester Police Rules and Regulations.

Hiring

- 1. When an officer vacancy occurs, the commission shall first obtain the authority to hire from the First Selectman. This is to ensure that the funds needed to hire an officer are not needed for some other purpose.
- 2. The First Selectman's office shall do any necessary advertising for the position.
- 3. The commission shall designate the hiring process to be followed after consulting with the Resident Trooper Supervisor.
- The Resident Trooper Supervisor shall oversee the hiring process enacted by the commission including all testing, background checks, and interviews.
- 5. Any meeting of the commission for hiring purposes must be a warned meeting with agenda and minutes. The commission may enter executive session as provided for in the Freedom of Information Act.
- 6. The commission shall either vote to make an offer to a candidate or will empanel a subcommittee to make the decision and vote to make an offer. Any vote by the commission or a subcommittee must be done in a warned meeting with an agenda and minutes. The commission or subcommittee may enter executive session as provided for in the Freedom of Information Act.
- 7. The commission is the sole authority that decides who to hire.
- 8. All offers shall come from the First Selectman's office after the Police Commission or subcommittee has voted to hire.

Promotions

- 1. The commission shall only promote officers when there is a budgeted position to be filled.
- 2. If the commission wishes to promote an officer and there is not a budgeted position, the commission shall obtain the necessary budget transfers from the Board of Selectmen and Board of Finance. Once the transfer is complete, the commission may conduct the promotion.
- 3. All promotions must be in accordance with the collective bargaining agreement.

Discipline

- 1. All discipline must be in accordance with the collective bargaining agreement.
- 2. For any action that may result in discipline greater than a written reprimand, the commission shall immediately inform the First Selectman prior to taking any action so that legal counsel may be consulted.

Collective Bargaining

- Prior to the commencement of collective bargaining with the police union on successor contracts, the First Selectman shall meet in executive session with the commission. The commission shall make the First Selectman aware of their concerns and recommended changes to the contract.
- The First Selectman shall negotiate on behalf of the town. The First Selectman may involve others, including commission members, in negotiations.

Annual Budget

- 1. The commission shall recommend a police department budget to the First Selectman for the next fiscal year by January 1st.
- 2. The First Selectman shall advise the Police Commission of any proposed changes to the budget and allow them to comment.
- 3. While the commission may make recommendations, it is ultimately the First Selectman's budget that will be presented to the Board of Selectmen and the Board of Finance.

Budget Management

- 1. Budget management ultimately rests with the Board of Selectmen and the Board of Finance. The boards have the authority to adjust the budget and staffing as they deem appropriate throughout the budget year as they would with any other department.
- 2. The Resident Trooper Supervisor shall have daily management of the police department budget.
- 3. Should a budget transfer be required, the Resident Trooper Supervisor shall make that recommendation to the commission and/or the commission, in consultation with the Resident Trooper Supervisor, shall make the recommendation. The commission shall forward any transfer request to the Board of Selectmen.

All actions shall be governed by sections 18-27 through 18-39 of the town ordinances and sections 7-274 through 7-300 of state statutes.

CHARTER

ARTICLE VII Appointed Officials and Appointed Boards

§ C-701. Appointed Officials.

The Board of Selectmen shall appoint the following Appointed Officials and such other Appointed Officials as required by the General Statutes:

A. Assessor.

The Board of Selectmen may appoint any other Appointed Officials as permitted by the General Statutes or this Charter.

§ C-702. Appointed Boards.

The Town shall have Appointed Boards as created pursuant to this Charter or required by the General Statutes; all of whose members shall be appointed as provided in this Charter.

§ C-703. Eligibility and Appointment of Appointed Officials.

Eligibility for appointment of Appointed Officials shall be governed, where applicable, by the General Statutes and/or the standards adopted by the Board of Selectmen. All Appointed Officials shall be appointed by the Board of Selectmen pursuant to procedures as adopted by the Board of Selectmen or permitted or required by the General Statutes.

§ C-704. Removal of Appointed Officials.

Appointed Officials shall be removed by the Board of Selectmen. If a removal procedure for a particular Appointed Official is not provided for in the General Statutes, then the Board of Selectmen may remove for any reason any Appointed Official, provided that such Appointed Official be notified in writing of the grounds for removal and given an opportunity to appear before the Board of Selectmen to respond to the grounds identified. If such Appointed Official desires such a meeting, such Appointed Official shall so notify the Board of Selectmen in writing within seven (7) days after notification of the grounds for removal. Such meeting shall be public only if such Appointed Official so requests. Such meeting shall be held no less than seven nor more than thirty (30) days after notification of the grounds for removal. The decision of the Board of Selectmen shall be final. The date of notification of the grounds for removal shall be deemed to be the date of delivery if delivered by hand and two (2) days after the postmark if delivered by mail.

§ C-705. Eligibility and Appointment of Members of Appointed Boards.

A. All Members of Appointed Boards shall be appointed by the Board of Selectmen pursuant to procedures adopted by the Board of Selectmen. Only Electors of the Town who do not

TOWN OF COLCHESTER POLICE COMMISSION BYLAWS

Amended 01/24/2011

SECTION 1. PURPOSE AND AUTHORIZATION

The name of the Commission shall be the "Town of Colchester Police Commission," which hereinafter in this document is referred to as "the Commission." The Board of Selectmen shall appoint a five-member Police Commission. The powers, duties, organization and term of appointment for the Police Commission shall be governed by the General Statutes and Section 214 of the Town Ordinances. (Charter, Article IX, C-901).

The Commission shall have the authority and responsibility for the general supervision and management of the police officers of the Town of Colchester and the property and equipment used in connection therewith. (Colchester Code, Chapter 18, Article VIII, Section 18-30A).

SECTION 2. POLICE COMMISSION OFFICE

The office of the Commission shall be the Colchester Town Hall where the Commission records will be maintained. All correspondence shall be addressed to the Commission at: Office of the First Selectman, 127 Norwich Avenue, Colchester, CT 06415. Copies of all the agendas, minutes and resolutions of the Commission shall be stamped in and posted with the Office of the Town Clerk and put on the Town website within timelines applicable to each document.

SECTION 3. MEMBERSHIP

- A. The Commission shall consist of five (5) members appointed by the Board of Selectman.
- B. All members of the Commission shall participate fully in Commission meetings and activities and shall have such duties as may from time to time be assigned by the Commission.
- C. Resignation from the Commission shall be in written form and transmitted to the Chairman who shall promptly forward same to the First Selectman.

SECTION 4. COMMISSION MEETINGS

The Commission shall meet at 6:30 p.m. on the fourth Monday of every month, except when the Town Hall is closed due to public holiday or some other reason. In the event of such a scheduling conflict, an alternative meeting date may be scheduled by the Commission.

- A. All meetings of the Commission are open to the public, as required by the Connecticut General Statutes, unless otherwise specified.
- B. For, purposes of determining whether the Commission may conduct business, a majority of sitting Commission members shall constitute a quorum, but in no event shall a quorum consist of less than three (3) members.
- C. Minutes of the Commission meetings and hearings shall be kept and published in accordance with the Connecticut General Statutes.

D. All mail addressed to the Commission shall be presented by the Chairman to the Commission at its first meeting held after such mail has been delivered. All mail shall be deemed 'received' when so presented.

SECTION 5. COMMITTEES & COMMITTEE CHAIR

- A. From time to time, the Commission may appoint such committees as may be deemed necessary or desirable. Any committee so appointed shall have the duties or responsibilities assigned to it at the time of appointment. The meetings of any committee so appointed are open to the public as required by the Connecticut General Statutes.
- B. Minutes of all committee meetings and hearings shall be kept and published in accordance with the Connecticut General Statutes.
- C. All mail addressed to any committee shall be deemed addressed to the full Commission and shall be treated in the same manner as set forth in Section 4, paragraph D.

SECTION 6. AMENDMENTS

These bylaws may be amended from time to time as deemed necessary or desirable by the Commission with a minimum of thirty (30) days notice of such proposed amendment being sent in writing to all Commission members and a 2/3 affirmative vote of the Commission.

SECTION 7. EFFECTIVE DATE

Bylaw amendments shall take effect immediately upon adoption by the Commission unless a proviso is also adopted specifying an implementation date.

All copies of these bylaws shall specify the effective date on all pages and amended date(s) on the last page.

SECTION 8. PARLIAMENTARY AUTHORITY

The rules contained in the current edition of Roberts Rules of Order shall govern the Commission in all cases to which they are applicable and in which they are not inconsistent with these bylaws, any special rules of order adopted by the Commission, Town of Colchester Charter or Ordinances, Board of Selectmen directives, or State statute.
