I have reviewed the proposed town and BOE budgets for Colchester. I am in favor of accepting both budgets as written and do not think it is prudent to reduce the BOE budget by \$275,000. The increase does not represent superfluous spending. The 2.78% increase is worthwhile and does not reflect

egregious spending. The 8% increase in the town budget does seem excessive, until one looks at what the expenditures are. Improving the RecPlex (including irrigation), adding police services, and "fixing" things that are broken do cost money.

I have also perused other town budgets, their mill rates from last year and their possible mill rates for next year. While I understand comparing towns is like comparing apples to oranges, what is clear is that Colchester's mill rate will not increase to be more than other towns with a similar population. What is also clear is that if Colchester does not make improvements to the shared community facilities and services, businesses will not want to stay, locate, or relocate here. Revenue will decrease and both the town and school will suffer.
