As it stands, this budget still does not address all the needs in this town, but I understand the consideration to not put an undue burden on taxpayers. To the Board of Finance and the Board of Selectmen,

I have lived in Colchester for the past 11 years and have the privilege of now raising my children in town. Every year I listen carefully to the budget discussions and I am always concerned about the resistance to investing in the future of our town. Over the past few years I am deeply disappointed in some members of the Board of Finance failing to recognize the needs we have in town. This year I feel the need to speak up.

The budget process in Colchester is getting increasingly difficult and the services in town have slowly been taken away due to the reductions made every year. Since moving to town I have heard of many people leaving town hall because of the lack of raises coupled with the increased workload leading to town employees leaving for other towns, at higher salaries and increased professional respect. I have had to increasingly pay for services in town because the town is less able to maintain public spaces. Town events, such as concerts on the green, the 57fest, and others either require incredible fundraising or are canceled because the budget doesn't support them. I understood the need to pull back budgets last year in a time of need, but throughout the years we have slowly been pushing off costs to the "next year's" budget and then pushing things off again the next year. It always seems to be a small contingent of voices that are pushing for more and more reductions in the proposed budgets, which means that the overall spending is reduced because of the rising costs of goods every year. The inability of this Committee to identify and secure the needed revenue to provide for the needs and interests of the community is deeply concerning. Deferring projects and underfunding services does not speak to a commitment to building a strong, vibrant community.

Every year I hear from the same familiar contingent of negative voices that we are going to lose taxpayers if we raise taxes. What you don't hear is that you are losing taxpayers because the town is losing the things that attracted them here in the first place. I personally have known five families that have moved out of Colchester, not because the taxes were too high, but because the events and services that brought their family to town have either been canceled or now are cost prohibitive. They moved to towns where services are provided, parks and fields are maintained and updated, and schools are valued by the community of taxpayers with no children in the system. I was infuriated that during a discussion of the budget, the first thing on the chopping block was playground equipment so young families can enjoy our RecPlex. The casual way this was thrown out by members of the Board shows a lack of caring about young families in our town. The company and town came up with an incredible deal to subsidize the cost of an expensive playground and the Board seems to only be looking to cut costs and not invest in the future of this town. This goes for many items in the budget discussions and often appears that some members of the Board of Finance find it easier to attack the person that proposed the budget item rather than the merits of why the item was proposed.

I am also astounded by the utter lack of investment in Colchester Public Schools. I have been following the budget process for years and it seems that the proposed budget is consistently reduced to a point where it goes to paying for essential services and there is a lack of investment in improvements, training, and supplies for the district to stay current with other schools in the area. I am an educator and have had the privilege to visit and work with other districts, work with and in other schools, and have my children in Colchester Public Schools. Our teachers are dedicated to providing the best education for our students, but every town and city in the country says that about their teachers. I have seen teachers at all levels work towards improving their practice and becoming better teachers but there has been a consistent lack of investment from the town so teachers are provided funding to help attend conferences, get training from professionals, or obtain supplies. Colchester is falling behind current trends in education because there is a lack of investment in the future of our children and our community. Local funding for our schools compared to towns around us is the second lowest in the area based on the 2018-2019, only beating Montville by \$117 per student and was 4th lowest in overall funding per pupil when compared to Marlborough, East Hampton, Montville, Hebron, Salem, Glastonbury, Region 8, Middletown, Lebanon, and East Haddam.

After listening to the budget presentations I strongly support the proposals from the Town and the Board of Education as proposed. The proposals meet the needs for the coming fiscal year while also responsibly planning for the future. I encourage the Finance Committee and the Selectboard to stand behind these budget proposals. Furthermore, I encourage the Finance Committee and Selectboard to

adopt a growth mindset and begin looking for opportunities to invest in the community, not just widdle away services and push off fundraising responsibilities to community members. We should not have to argue with our community officials about supporting investments in the community where we have chosen to live and work.

Thank you for reaching out. I appreciate your comments and will note that the entire board is working through the budget to reduce the impact to tax payers through reductions to the request and other

funding sources. I do believe all members are in agreement that we will not put forward a mill rate increase of 1.77 which is what the original budget proposal shows.

Regarding your comment about the Planning Department, I believe you may be referencing a comment made by a member of the Planning and Zoning Commission at a recent meeting. (Another member of the same commission also voiced support for the requests last night but did not identify herself as a member when she spoke.) I do not believe the Planning Department has taken a stance on the budget based on my conversations with the Town Planner who has spoken often of the need to invest in our community in order to attract business. If you have heard something different from the Planning Department, please let me know as it would be important information to consider as we prepare to move the budget forward.
