Dear First Selectman,

Please include this communication in the BOS correspondence.

As a citizen of this town, I expect my Board of Selectmen to openly discuss concerns of and review documentation that may reveal misappropriation of town funds. To not do so would be highly unethical and egregious to the town. This documentation is entirely public and should be viewed in the public vein.

If this documentation reveals evidence of misconduct, willful and material neglect of duty, or incompetence in the conduct of such town clerk's office, then I have no qualms in submitting a complaint in writing to the Attorney General pursuant to Connecticut General Statutes section 7-22, as is my right as a citizen of this town and a resident of this state. That statute requires the Attorney General to investigate the charges set forth in such a complaint as he deems proper and shall if warranted by the evidence prepare a statement in writing of the charges together with a citation in the name of the state commanding the town clerk to appear before a judge of the Superior Court.

I also know William Tong, as I have worked with the Attorney General's Office over 17 years on a number of cases, including one heard in State Supreme Court. And based on my knowledge of AG Tong and his Assistant AGs, I don't believe that such a complaint would be flippantly reviewed or summarily dismissed.

So, it's irrelevant whether or not the BOS decides to investigate the town clerk. However, I still find it appalling that the Wayward Sisters, Rosemary and her two sycophants would attempt to suppress this information from being presented the citizens of Colchester and would move to not require these types of financial activities regularly reported to our Finance Department and such expenditures approved by the Finance Director.
