Attached is the YTD printout for General Fund expenditures as of transactions posted thru 12/31/23. I reviewed a few accounts that did not make sense, and concluded that there are numerous transactions that need to be corrected between accounts, and the remaining payroll encumbrances are overstated as the number of remaining pays being used in the calculation is overstated by ½ pay period (5 days).

Unfortunately, it may take a significant amount of effort/time to identify and correct everything before the reports can be relied upon in making decisions, as I suspect we may have to review every account.

Let me know when you want to meet to discuss a detail strategy in how we manage what needs to be done.
