Installations and Revisions of Traffic Control Signals in various Connecticut towns:

The Department of Transportation (Department) is developing plans to upgrade existing traffic control signal equipment or install new traffic control signal equipment to meet current Department standards at 15 locations in the cities and/or towns of Colchester, East Lyme, Groton, Montville, New London, Norwich, Salem, Stonington, Windham and Woodstock. At applicable locations, pedestrian control features (countdown pedestrian indications, accessible pushbuttons, sidewalk ramps) will be upgraded in an effort to improve accessibility and pedestrian safety. The Department will coordinate with the City/Town during the design phase. The following intersections are included:
