6. LPC FUNDING - VAPE DETECTORS

Answers to additional questions about the Soter Technology Vape Detectors were forwarded to Bacon Administration. Administration is working with the Board of Education to develop a policy.

7. DFC UPDATES - YR 4 PLANNING

- The year four budget proposal, due March 15, is in progress.
- The Youth Voices survey, produced by B. Weyland Smith Consulting, LLC is being considered instead of SERAC. The services and products from B. Weyland Smith are considered to be a better value and the survey reporting is easier to understand and utilize. Prices include \$7000 for the survey and evaluation. An additional monthly \$1000 for Evaluation Services would provide ongoing program evaluation, coalition capacity assessment, focus groups, a Community Survey, a Coalition Assessment Survey, and Sustainability Planning.

• The Core Measures Youth Survey was last conducted in 2022, due in February 2024. The Developmental Assets survey was last conducted in 2021, due in October 2023.

8. YSAB UPDATES

- Blair Windsor has filled the vacant position at Social Services. Blair also works at Bacon Academy.
- The open Social Services position has been filled.
- The IRB Case Manager position has also been filled.
- Youth Services summer trip planning is underway.
- Youth Services is deciding, with the help of the Board of Selectmen, how to use the \$42,000 from the federal and multi-state opioid settlement with Janssen Pharmaceuticals.

- More Tik Tok visibility was discussed. Charity noted that the Youth Action Council (YAC) has produced Tik Tok videos focused on drug prevention messaging.
- Chris offered to talk with student ambassadors about creating mental health and substance abuse Tik Tok skits.
- Craig offered to Invite a representative from the Bacon Academy drama club to discuss the idea of creating skits to educate parents/youth on mental health and substance abuse
- Podcasts were suggested, breaking them into meaningful segments and distributing on social media.
- Charity discussed Dave Koji's ideas of daily mental health messaging to students created by coalition and distributed by teachers to the google classroom pages. She also talked about Dave's mental health video concept focusing on parents' and children's similar experiences.
- It was suggested to use Google Classroom Messaging to collect ideas from youth on educational topics.
- Drug messaging or Developmental Asset education could be possible student capstone projects.
- It was agreed to formally table the current approach to community conversations due to poor attendance and focus on moving forward to solidify our new ideas.
- Russ Melmed and Blair Windsor and Ann Marie Maffuid will be joining the Marketing and Media subcommittee to help work on this initiative.
