Val stated that the State is not pushing for this to be used for youth prevention. Mostly intended for abatement of the current crisis. Craig suggested that funds could be used for diversion programs and first responder wellness programs. Russ asked if we should seek community input in terms of proposals and use the advisory board to evaluate them. Students present felt that youth in Colchester have been sufficiently educated about opioids. Discussion around what structure should we put around seeking proposals — should we conduct a survey to solicit input? Craig Scheel presented a proposal from Sean Shoemaker to utilize opioid settlement funds for a K9 Wellness program. Questions about liability, ongoing costs, utilization, deployment, expectations. Unanimously approved motion to invite Sean to a future meeting to present more details.
