7. Local Prevention Council

- **a.** 2021 DFC Grant; received letters of support from state leaders
- **b.** SERAC Local Prevention Council grant is due July 31st; Michele Wyatt (tax collector and Lion's) and Carol Wikarska (business owner) represent additional sectors. Last year funds were used to support addiction counselors at schools and pay for consultant. This year a portion of the grant must be used to provide vaping education and prevention. Ideas included: paid social media education campaigns, webinars for school aged youth during health classes, recording an "In Plain Sight" training for parents, purchasing THC test kits for the school and/or parents.
